AtCor Medical Holdings Limited (ASX:ACG) – Commitments Test Entity – Fourth Quarter Report

AtCor Medical today releases its quarterly cash flow report for the period ending 30 June 2008.

Cash at quarter end was \$3,316,000. Net cash outflows of \$409,000 were recorded for the quarter, a \$438,000 improvement over last quarter. Outflows for the financial year ended 30 June were over \$1 million lower than prior financial year, driven largely from improved receipts from customers.

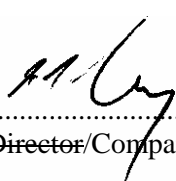
